The application for Duty exemption of M/s ICOMM Tele Ltd., for import of one set of Cannon A-100 P.U. foaming machine and one press for manufacture of P.U. Sandwich Panels for Telecom shelters.

M/s ICOMM Tele Ltd., is a large manufacturer of Tele Communications equipment for cellular, Fixed, Internet and Satellite telephone operators in India. They also manufacture transmission towers. They have four factories in Andhra Pradesh with Head office at Hyderabad.

Telecom equipment specially for mobile telephones are housed in special P.U foam insulated shelters which are made from P.U. Foam Sandwich Panels. The company recently started manufacturing P.U. Sandwich Panels in 2005 for which they imported a foaming machine and platen press and received duty exemption assistance.

They are now undertaking an expansion programme and are importing one more foaming machine and platen press for which they have applied for duty exemption. The details of the machines being imported is given in the table below. They will be using HCFC-141b as the non-ODS foam blowing agent.

The application of **M/s Subros Ltd.**, for Duty exemption for import of equipment / toolings required for manufacture of new Air-conditioning systems/ A.C. kits of (R-134a type).

M/s Subros Ltd., is the largest manufacturer of car Airconditioners in India. They are OEM suppliers to M/s Maruti Udyog Ltd., and also supplies to Tata motors, Mahindra and Mahindra for all models of passenger cars.

They started with a capacity of 50,000 units per annum and gradually increased to appox. 1 million units. They have a fully equipped plant at Noida and about 2 years back opened a new plant with equal capacity at IMT, Manesar to cater to the need of growing car manufacturing industry in India.

They have now decided to set up another plant at Chakan Industrial Estate, Pune to cater to the needs of Tata Motors situated near by. They are also augmenting their facilities at Manesar and at Noida to cater to the needs of new models of cars being introduced by M/s Maruti Udyog Ltd.,

For the new plant at Pune and for augmenting facilities for existing plants at Noida and Manesar M/s Subros is now importing 18 Sets of equipment and have applied for duty exemption for the same.

The total cost of the equipment being imported is Rs. 619.81 Lakhs and appox. Duty payable @ 15% in 92.97 Lakhs.

All these equipment are general purpose machines needed for manufacture of Mobile Air Conditioners using non-ODS R-134a

refrigerant and have been approved in their earlier applications. The chillers, air dryers, temperature controller, robot hopper loaders are all accessories of injection moulding machines needed for manufacture of plastic body components of MACs.

It may be mentioned that M/s Subros has received duty exemption assistance for MAC manufacturing equipment of different types eight times earlier. This is their 9^{th} application. Pune plant is their third expansion project.

The company has submitted all the supporting documents.

The application of M/s Jindal Soft Italia Seating Pvt. Ltd., Pune for duty exemption for import of one High Pressure P.U. foaming machine from Germany for manufacture of two wheeler seats and other accessories.

M/s Jindal Soft Italia Seating Pvt. Ltd., is a recently (February, 2006) incorporated company with the avowed aim of manufacturing and assembling P.U foam seats for two and three wheeler motor vehicles. They have considerable experience of manufacturing P.U foam articles earlier through their sister company M/s Sarvapriya Industries Ltd., Gurgaon who had received funding from MPMF for conversion to non-ODS foam blowing agents in the manufacture of two wheeler seats.

M/s Jindal Soft Italia Seating Pvt. Ltd., is now installing a new large unit at village Khed, near Pune (Maharashtra) as a part of their large expansion programme. They aim at manufacturing in first phase two wheeler seats for Bajaj Auto Ltd., and three wheeler seats for Piaggio under a letter of Intent (LOI) agreement. They expect to supply more than 30% of the need of these two companies. The capacity of plant on single shift basis will be 18.5 lac seats per Annum.

For this new project at Khed (Pune), they are importing One High Pressure Foaming machine with accessories form M/s Krauss Maffei, Germany and have applied for duty exemption for the same as they are going to use non-ODS foam blowing technology.

The details of the machinery being imported is given in the Table on next page.

The company claims that with better technology they will be able manufacture premium quality seats which are flame retardant, low density and water as well as weather resistant.
