**ORDER**

**Sub.: Reconstitution of Standing Committee on Monitoring - Regarding**

1. The Ministry of Environment, Forest and Climate Change hereby reconstitutes the Standing Committee on Monitoring of the Empowered Steering Committee on the Montreal Protocol, comprising the following:-

I.	Chairman, Central Pollution Control Board (CPCB)	Chairman
II.	Representative of Department of Chemicals & Petrochemical, Government of India	Member
III.	Representative of Ministry of Micro, Small and Medium Enterprises (MSME), Government of India	Member
IV.	Representative of Department for Promotion of Industry and Internal Trade, Government of India	Member
V.	Representative of Directorate General of Commercial Intelligence and Statistics (DGCIS)	Member
VI.	Representative of Directorate General of Foreign Trade (DGFT)	Member
VII.	Representative of Directorate of Plant Protection, Quarantine and Storage, Ministry of Agriculture & Farmer's Welfare, Government of India	Member
VIII.	Representative of Director, Institute of Pesticide Formulation Technology, Department of Chemical and Petrochemicals, Government of India	Member
IX.	Representative of Director, National Institute of Pharmaceutical Education and Research, Mohali, Department of Pharmaceuticals, Government of India	Member
X.	Representative of Director, CSIR-Indian Institute of Chemical Technology (IICT), Hyderabad	Member
XI.	Officer-in-Charge (Ozone Cell)	Member-Secretary

2. There shall be a "Working Group" of the Standing Committee on Monitoring with following membership:

I.	Representative of Director, Institute of Pesticide Formulation Technology, Department of Chemical and Petrochemicals, Government of India	Member
II.	Representative of Director, National Institute of Pharmaceutical Education and Research, Mohali, Department of Pharmaceuticals, Government of India	Member
III.	Representative of Director, CSIR-Indian Institute of Chemical Technology (IICT), Hyderabad	Member
IV.	Member Secretary, Central Pollution Control Board	Member
V.	Officer-in-Charge (Ozone Cell)	Convener

3. The "Working Group" shall specifically deal with issues on use/manufacture of controlled Substances for feedstock uses inter alia including qualifying process for feedstock use, monitoring and data reporting etc, the processes for which have not been specified by the Technology and Economic Assessment Panel of the Montreal Protocol (TEAP). The Working Group shall meet every three months or as required. The Working Group shall provide recommendations on qualifying process for feedstock use, monitoring and data reporting of ODSs etc. The recommendation of the working group, shall be forwarded to the Ozone Cell, MoEF&CC for further necessary action. The proposals recommended by the Working Group for registration under Ozone Depleting Substances (Regulation and Control) Rules, 2000 as amended from time to time, shall be apprised to the Standing Committee on Monitoring.

4. Representatives of State Governments/State Pollution Control Boards may be invited for the meeting, when projects pertaining to that State are taken up for monitoring.

5. The Committee shall have the following Terms of Reference:

- (i) To analyze, collate and recommend the Country data on production, import and export each of the controlled substances accordingly to Article-7 of the Montreal Protocol for onward submission to the Ozone Secretariat.
- (ii) To analyze, collate and recommend the data for Country Programme progress report to be submitted to Multilateral Fund Secretariat.
- (iii) Use/manufacture of ODSs for controlled and feedstock uses inter alia including qualifying process for feedstock use, monitoring and data reporting etc.
- (iv) Any such other matter as may be referred by the Ministry with reference to implementation of Montreal Protocol.


